DEPUTY DIRECTOR OF THE NEW MUSEUM, NEW YORK


TUESDAY, MARCH 20, 2018 10 - 11 AM Karen Wong is the Deputy Director of the New Museum, a mid-size museum renowned for its entrepreneurial platforms and mission: new art and new ideas. She co-founded the initiatives IDEAS CITY (2010), a residency and conference exploring the future of cities with the belief that art and culture are essential to our metropolises, and NEW INC (2014), the first museum-led incubator for art, technology and design. Both initiatives are models for the intersection of cultural and civic engagement.

As managing director of Adjaye Associates from 2000-2006 she helped build the foundation for an international architectural practice. She supports emerging architects in her role as a board member of Plus Pool (a self-cleaning floating public pool proposed for the East River) and a former board member of Storefront for Art and Architecture.

She sits on the boards of Rhizome, a platform for emergent artistic practices that engage technology and Apex for Youth, a mentoring and education program for under-served Asians. She also serves on the advisory council of National Sawdust, a nonprofit performance venue focused on new music. She graduated magna cum laude at Brown University with dual BA in Art History and Art Practice.

Recent museum conference keynotes took place in Toronto, Istanbul, Copenhagen, Athens, Paris, and she developed a design talk series for Google NYC. She is an Adjunct Assistant Professor at Columbia GSAPP where she teaches a seminar on culture production.

Andrew John Wit holds a master's degree from MIT and is an Assistant Professor at Temple University where he leads research, courses and workshops focused around novel building systems generated through light-weight composites, digital production tools and robotic systems. He is also a Co-Founder of the interdisciplinary research group WITO* Laboratory for Intelligent Environments, resides on the ACADIA board of directors where he is a technical co-chair for the 2018 conference in Mexico City and serves on the editorial board for the International Journal of Architectural Computing.

Wit's research and projects have been highly disseminated and recognized: UTenSAils (2007 AIA Best of Practice Award), the Advanced Fabrics Exhibition (2007 IFAI Outstanding Achievement Award), along with the widely-published tensegrity structure the Underwood Pavilion, the woven carbon fiber installations entitled rolyPOLY and carbon fiber kites of cloudMAGNET. Wit's work has been featured at numerous galleries, international conferences and refereed publications.


PENN LAW - DEPUTY DEAN

DR. SOPHIA LEE

Sophia Lee is a legal historian whose scholarship synthesizes constitutional and administrative law. She has written about administrative agencies' role in shaping constitutional law; civil rights and labor advocates' challenges to workplace discrimination during the early Cold War; and conservative legal movements in the post-New Deal era. Her book, The Workplace Constitution from the New Deal to the New Right, was published in 2014 by Cambridge University Press. Her articles can be found in the Yale Law Journal, the Virginia Law Review, and Law & History Review. She earned her J.D. and Ph.D. in history from Yale. Prior to joining the Penn Law faculty, she clerked for the Honorable Kimba M. Wood of the United States District Court for the Southern District of New York.

ASSOCIATE PROFESSOR, PENN DESIGN ARCHITECTURE

DR. FRANCA TRUBIANO

Franca Trubiano is Associate Professor in the Architecture Department at PENN Design and a Registered Architect with l'Ordre des Architectes du Quebec. She teaches in theories of building, environmental design, construction technology, emerging materials, integrated design, and high-performance buildings. In 2015, Franca was President of the Building Technology Educators Society (BTES) during which time she co-founded TAD (Journal of Technology, Architecture and Design), and acted as its Executive Editor until 2016. From 2014 -2016 she was a Member of the Editorial Board of the Journal of Architectural Education. She is presently completing a manuscript for Routledge which challenges the field of architectural theory to reclaim its origins in the art of building. Building Theories, a new Ethics for Architecture (Routledge), proposes an alternative definition of theory, one that valorizes the as yet untapped potential of 'thinking through building'. Her edited book Design and Construction of High Performance Homes: Building Envelopes, Renewable Energies and Integrated Practice (Routledge Press 2012), was translated into Korean in 2014, by the Korean Research Institute of Environmental Architecture. And Franca's essays have appeared in edited books Architecture and Energy (eds. Braham and Willis, Routledge Press, 2013) and Architecture and Uncertainty (ed. Benjamin Flowers, Ashgate Press, 2014).
